What is a U Visa?

A U-Visa is issued to victims of certain crimes who have suffered mental or physical abuse and who are helpful to law enforcement in the investigation or prosecution of criminal activity.

The Immigrant Affairs Unit is a certifying agency for the I-918 supplemental B non-immigrant status, known as the U-Visa. Our staff is able to certify U-Visa applications. To qualify for that certification, the victim must be fully cooperative in the prosecution of a case handled by the Richmond County District Attorney's Office.

Know Your Rights!

- You have the right to report a crime committed against you to the NYPD.
- You have the right to have the police or the District Attorney investigate a crime committed against you, without fear of repercussions, even if:
 - * You don't speak English; or
 - You don't understand the laws of the U.S.; or
 - * You are in the U.S. without any immigration status or documentation.

Immigrant Fraud Common Scams:

- Business or individuals who falsely represent themselves as attorneys, lawyers, immigration specialist or "Notarios" and provide legal advice without a license.
- Individuals who falsely promise to sponsor work visas and/or employment training for a fee.
- Employers who hire immigrants to do construction work or other jobs and then fail to pay them a legal wage.
- The production and purchase of false documents such as Driver's Licenses, Passports, Social Security, and Resident Alien cards/and/or other fraudulent documents.
- Business or individuals who offer assistance with housing services or health care enrollment, accept payment and/or disappear without providing the service.

Protect Yourself from Fraud and Scams:

- Never provide personal documents.
- Never provide information, over the phone, to someone who claims to be the IRS, a utility company, a federal employee or a debt collector.
- Never sign any blank documents or forms .
- Never sign a document you did not read.
- Always demand detailed paper receipts for any payments.
- Do not make payment with prepaid money card.
